**PRODUCT:** Harvest Apple Diced Pourable Fruit

**ITEM NUMBER:** 00105

**DESCRIPTION:** Diced Apples are mixed with a thickened, sweetened sauce, heated, and frozen in 35 oz. bottles.

**INGREDIENTS:** Diced Apples, Cane Sugar, Pears, Pear Juice, Water, Lemon Juice Concentrate, less than 1% of the following: Spices (Cinnamon, Nutmeg, Ginger Root Powder, Allspice), Citric Acid, Vanilla Extract, Guar Gum, Xanthan Gum, Malic Acid.

**PROCESSING:** Product is pasteurized following FDA guidelines for Juice HACCP: 21 CFR part 120.

### PHYSICAL PROPERTIES:

Brix:	33.0° – 37.0°
pH:	2.40 – 3.20
Viscosity:	7 - 11 cm/10 sec. (Bostwick at 40 - 50°F)
Piece Size:	Chunky apple pieces should pass through a 6.0 mm straw
Color:	Brown, typical of apple pie spices.
Flavor:	Typical of sweetened apple pie spices

### METAL DETECTION:

During production, inline metal detectors are challenged and calibrated hourly for adequate sensitivity to and rejection of the following test pieces:

- Ferrous 1.0mm
- Non-Ferrous 1.5mm
- Stainless Steel 2.0mm

**PACKAGING:** High density polyethylene (HDPE) bottles with induction seals and polypropylene (PP) lids, 6 bottles per corrugated case. Production lot number, time of fill and best used by date are printed on the bottle. Item number, production lot number and best used by date are printed on the case label.

### LOT CODE FORMAT:

Identifies the date of production and final four digits indicate the time of processing in 24-hour format [military time]

YYMMDD ##### YY = Year MM = Month DD = Day ##### = Military time

Example: 240711 1643 = July 11, 2024 at 4:43 pm

Production lot number, time of fill, and best used by date are printed on the bottle.

Product code and production lot number are printed on the case label.

Kosher (OU), Vegetarian, Vegan, Product of USA, made from domestic and imported fruit.

### BEST USED BY:

30 months when stored frozen in original unopened containers.

Use within 21 days after removal from frozen storage.

Store and ship frozen at or below 0°F (-18°C). To use, thaw refrigerated 12 – 24 hours.

Refrigerate after opening and use within 21 days after removal from frozen storage.
