**PRODUCT:** Tropical Diced Pourable Fruit

**ITEM NUMBER:** 00325

**DESCRIPTION:** Pineapple pieces are diced and mixed with a thickened, sweetened sauce of passionfruit juice, orange juice concentrate, and guava puree. Tropical FIH is packed in 35 oz. net weight plastic bottles and frozen to maximize product quality.

**INGREDIENTS:** Pineapple, cane sugar, water, passionfruit juice, guava puree, orange juice concentrate, less than 1% of the following: citric acid, guar gum, xanthan gum.

**PROCESSING:** Product is pasteurized following FDA guidelines for Juice HACCP: 21 CFR part 120.

**PHYSICAL PROPERTIES:**

Brix:	32.0° – 37.0°
pH:	2.7 – 3.3
Piece Size:	Chunky pineapple pieces should pass through a 6.0 mm straw.
Viscosity:	9 - 15 cm/10 sec. (Bostwick at 40 - 50°F)
Color:	Yellow pink, typical of passionfruit and guava colors.
Flavor:	Bright breezy, typical flavors of passionfruit, orange juice, and guava.

**METAL DETECTION:**

During production, inline metal detectors are challenged and calibrated hourly for adequate sensitivity to and rejection of the following test pieces:

- Ferrous 1.0mm
- Non-Ferrous 1.5mm
- Stainless Steel 2.0mm

**PACKAGING:** High density polyethylene (HDPE) bottles with induction seals and polypropylene (PP) lids, 6 bottles per corrugated case. Production lot number, time of fill and best used by date are printed on the bottle. Item number, production lot number and best used by date are printed on the case label.

### LOT CODE FORMAT:

Identifies the date of production and final four digits indicate the time of processing in 24-hour format [military time]

YYMMDD ##### YY = Year MM = Month DD = Day ##### = Military time

Example: 240711 1643 = July 11, 2024 at 4:43 pm

Production lot number, time of fill, and best used by date are printed on the bottle.

Product code and production lot number are printed on the case label.

Kosher (OU), Vegetarian, Vegan, Product of USA, made from domestic and imported fruit.

### BEST USED BY:

30 months when stored frozen in original unopened containers.

Use within 14 days after removal from frozen storage.

### STORAGE:

Store and ship frozen at or below 0°F (-18°C). To use, thaw refrigerated 12 – 24 hours.

Refrigerate after opening and use within 14 days after removal from frozen storage.
