PRODUCT: Strawberry Smooth Pourable Fruit, Shelf stable

ITEM NUMBER: 70009

DESCRIPTION: Strawberry puree is mixed with a thickened, sweetened sauce and pasteurized. Strawberry Smooth is packed in 32 fl oz net volume plastic bottles.

INGREDIENTS: Strawberries, water, cane sugar, less than 1% of the following: citric acid, guar gum, xanthan gum, fruit and vegetable juice (for color), natural flavors.

PROCESSING: Product is pasteurized following FDA guidelines for Juice HACCP: 21 CFR part 120.

PHYSICAL PROPERTIES:

Brix: 26.0° – 32.0°
pH: 2.80 – 3.10
Viscosity: 10 - 17 cm/10 seconds (Bostwick at 40 - 50°F).
Color: Dark red color, typical of strawberries.
Flavor: Tart and sweet, with no musty or objectionable flavor.

METAL DETECTION:

During production, inline metal detectors are challenged and calibrated hourly for adequate sensitivity to and rejection of the following test pieces:

- Ferrous 1.0mm
- Non-Ferrous 1.5mm
- Stainless Steel 2.0mm

PACKAGING: Polypropylene (PP) bottles with induction seals and polypropylene (PP) lids, 6 bottles per corrugated case. Production lot number, time of fill and best used by date are printed on the bottle. Item number, production lot number and best used by date are printed on the case label.

Identifies the date of production and final four digits indicate the time of processing in 24-hour format [military time]

YYMMDD ##### YY = Year MM = Month DD = Day ##### = Military time

Example: 230121 1643 = January 21, 2023 at 4:43 pm
