PRODUCT: Strawberry Diced Pourable Fruit, Shelf stable

DESCRIPTION: IQF strawberries are washed in Tsunami 200 (antimicrobial agent), diced, and mixed with a

thickened, sweetened sauce and pasteurized. Strawberry Diced is packed in 35 oz net weight

plastic bottles.

INGREDIENTS: Strawberries, water, cane sugar, less than 1% of the following: citric acid, fruit and vegetable

juice (for color), guar gum, xanthan gum, natural flavors.

PROCESSING: Product is pasteurized following FDA guidelines for Juice HACCP: 21 CFR part 120.

PHYSICAL PROPERTIES:

Brix: $26.0^{\circ} - 32.0^{\circ}$ pH: 2.80 - 3.10

Viscosity: 7 - 14 cm/10 seconds (Bostwick at 68 - 72°F).

Color: Red color with pieces of strawberries.

Flavor: Sweet, fruity flavor, with no musty or objectionable flavor.
