**PRODUCT:** Mixed Berry Diced Pourable Fruit

**ITEM NUMBER: 90806** 

**DESCRIPTION:** Strawberries, Blackberries and Cherries, are diced and mixed with a sweetened, thickened

sauce, packaged and frozen in 35 oz bottles.

**INGREDIENTS:** Fruit (strawberries, blackberries, cherries), cane sugar, water, less than 1% of the following:

guar gum, xanthan gum, citric acid.

**PROCESSING:** Prior to dicing, fruit is washed with a diluted peracetic acid solution.

Product is not pasteurized.

PHYSICAL PROPERTIES:

Brix: 29.0° – 34.0° pH: 2.80 – 3.50

Piece Size: Chunky strawberry, Marion blackberry, and cherry pieces should pass through

a 6.0 mm straw

Viscosity: 7 - 11 cm/10 sec. (Bostwick at 40 - 50°F)

Color: Dark red color, typical of mixed berries and cherries, some seeds are visible Flavor: Typical of ripe, sweetened strawberries, Marion blackberries, and cherries
