DESCRIPTION: Passion fruit puree is mixed with a thickened, sweetened sauce and pasteurized. Passion Fruit

Smooth is packed in 32 fl oz plastic bottles and frozen to maximize product quality.

INGREDIENTS: Passion fruit puree, cane sugar, peach puree, guar gum, xanthan gum.

PROCESSING: Product is pasteurized following FDA guidelines for Juice HACCP: 21 CFR part 120.
