preservatives and no additives.

**INGREDIENTS:** Mango Juice Concentrate, Water.

**PROCESSING:** Aseptic Mango Juice Concentrate is pasteurized at 195°F or higher for a minimum of 30 seconds for

commercial sterility. It is cooled and aseptically packaged. Enzymes may be used as processing aids. Aseptic products are guaranteed to comply with FDA, Juice HACCP: 21 CFR Part 120, applicable state and

local laws and regulations.
