- **PRODUCT:** Aseptic Pineapple Juice Concentrate
- ITEM NUMBER: PI391, PI393
- **DESCRIPTION:** Aseptic Pineapple Juice Concentrate is prepared from Pineapple juice concentrate. The product contains no preservatives and no additives.
- **INGREDIENTS:** Pineapple Juice Concentrate, Water.

PROCESSING: Aseptic Pineapple Juice Concentrate is pasteurized at 195°F or higher for a minimum of 30 seconds for commercial sterility. It is cooled and aseptically packaged. Aseptic products are guaranteed to comply with FDA, Juice HACCP: 21 CFR Part 120, applicable state and local laws and regulations.
