PRODUCT: Aseptic Lemon Juice Concentrate

ITEM NUMBER: LEM391/LEM393

DESCRIPTION: Aseptic Lemon Juice Concentrate is prepared from lemon juice concentrate. The product contains no preservatives and no additives.

INGREDIENTS: Lemon Juice Concentrate, Water.

PROCESSING: Aseptic Lemon Juice Concentrate is pasteurized at 195°F or higher for a minimum of 20 seconds for commercial sterility. It is cooled and aseptically packaged. Aseptic products are guaranteed to comply with FDA, Juice HACCP: 21 CFR Part 120, applicable state and local laws and regulations.

STATUS: Aseptic, Kosher (Orthodox Union), Vegetarian, Vegan.

EXPIRY AND STORAGE:

18 months shelf life at ambient temperatures (<75°F). Product is commercial sterile and shelf stable, no refrigeration is necessary for food safety of unopened bags. Refrigerated storage is recommended to maintain optimal color. Opened packages must be frozen to prevent spoilage.
