**PRODUCT:** Aseptic Mango Juice Concentrate

**ITEM NUMBER:** MG392 / MG316 / MG337

**DESCRIPTION:** Aseptic Mango Concentrate is prepared from mango juice concentrate. The product contains no preservatives and no additives. Puree is processed through a final finisher screen that is 0.033".

**INGREDIENTS:** Mango Juice Concentrate.

**PROCESSING:** Aseptic Mango Concentrate is pasteurized at 195°F or higher for a minimum of 30 seconds for commercial sterility. It is cooled and aseptically packaged. Enzymes may be used as processing aids. Aseptic products are guaranteed to comply with FDA, Juice HACCP: 21 CFR Part 120, applicable state and local laws and regulations.

Aseptic, Kosher (Orthodox Union), Vegetarian, Vegan.

### EXPIRY AND STORAGE:

Product is shelf stable, no refrigeration is necessary for food safety of unopened bags. Refrigerated or frozen storage is highly recommended for optimal color and flavor quality. Thawed product should not be refrozen. Shelf life for frozen storage is 2 years, 18 months at refrigerated temperatures, and 12 months at ambient.
